#### **POLICY STATEMENT:**

To establish a Naming of Corporate Assets Policy for the Corporation of the Town of Gananoque.

#### **OBJECTIVE:**

This policy is to encompass the naming of any corporate asset including parks, open spaces, facilities, streets and other municipal buildings of properties. The final decision for naming of corporate assets will rest with Town Council, including naming opportunities as a result of gifts and sponsorships. The naming of a particular corporate asset is important for public awareness, promotion and emergency access. Therefore, naming will be consistent with the Town of Gananoque's vision and will not contravene any policy of the Town nor reflect negatively on the Town's public image.

### INTENT:

The intent of this policy is to:

- Continue the current traditional practice of naming municipal property, buildings and park elements after significant geographical, neighbourhood and historical elements;
- Recognize on an exception basis, significant contributions that organizations or individuals have made to the public life and the well-being of the people of the Town of Gananogue;
- Provide direction on the approval process to name, rename or dedicate municipal property, buildings or park elements.

### SCOPE:

The Naming of Corporate Assets Policy is applicable to all departments of the Corporation of the Town of Gananoque.

#### **POLICY STATEMENTS:**

**1.** There are four main types of naming situations addressed by this policy:

- Opening of a new corporate asset or reopening of a corporate asset following refurbishment
- Honouring individuals or groups
- Recognizing international, national or provincial events/competitions
- Providing recognition of gifts, sponsorships and joint ventures
- 2. The selection of a name will be based on a number of criteria including but not limited to:
  - A longstanding local area identification with the residents
  - Understandable to the majority of citizens in Gananogue
  - Consistent with any other applicable policies and naming guidelines
  - Assists with emergency response situations by being consistent with street names and geographical locations and meeting the requirements of Gananoque Emergency Services
  - Consistent with sponsorship levels
- **3.** Preference will be given to names that:
  - Give a sense of place, continuity and belonging to reflect the geographic location, community, neighbourhood or street where the corporate asset is located and/or;
  - Recognize the historical significance of the area and/or;
  - Reflect unique characteristics of the site and/or;
  - Reflect the type of service offered and/or;
  - Are in keeping with a selected theme and/or;
  - Honour individuals, living or deceased, who have made a significant contribution to the community
- 4. Names will not be chosen that:
  - Cause confusion due to duplication or names sounding similar to existing locations within Gananoque
  - Are the names of tobacco companies
  - Lend themselves to inappropriate short forms or modifications
  - Are discriminatory or derogatory considering race, gender, creed, political affiliation, or other similar factors

- Recognize the birth, marriage or anniversary of specific individuals (this can be done through individual dedications of benches and trees through Public Works, Culture and Recreation Department)
- **5.** Names of persons, organizations, corporations, foundations or their families will be considered when they have made a significant contribution to the Town by:
  - Enhancing the quality of life and well-being of the Town
  - Contributing to the historical or cultural preservation of the Town
  - Contributing toward the acquisition, development or conveyance of land or building
  - Achieving excellence in their endeavours and representing Gananoque in a meritorious manner and/or;
  - Where there is a direct relationship or association that exists between former place of residence of the person or group and the asset to be named
- **6.** Naming in honour of elected or appointed public officials, Town administrative officials, staff, or any individual person shall occur posthumously (with a minimum time period of 5 years after their death)
- 7. Where the name of an individual is recommended after an in camera discussion, consent shall be obtained from the individual or their next of kin prior to Council's public consideration.
- **8.** Where the naming opportunity is as a result of a sponsorship or gift the following factors must be considered:
  - The significance of the contribution made relative to the construction and operating costs of the item being named
  - The cost of establishing the naming option (e.g. cost of the signage to be paid by the applicant unless the Town has made the request for the name change)
  - Sunset clause associated with the length of time that the name will be used.
     Naming agreements may be renewed if the appropriate gift or sponsorship is received.
- 9. Existing names will not be changed without consideration of the historical significance of the existing name, the impact on the individual or organization previously named, the cost and impact of changing existing signage, rebuilding community recognition and updating records (i.e. letterhead, databases, promotional materials) Each application will be considered on a case-by-case basis.

### **APPLICATION REVIEW AND APPROVAL PROCESS:**

- **1.** Applicant(s) shall submit a written request for civic naming to the Town Clerk. The written request shall provide the following:
  - Background information concerning the rationale for consideration of the request;
  - Biographical information if named after an organization or individual; and
  - Documentation including letters from organizations and individuals providing substantial support for the request.
- 2. Each application for naming/renaming shall undergo a process which will:
  - Review the application for conformity with this policy
  - Circulate the application to the appropriate internal stakeholders for comment on the suitability of the application
  - Discuss in camera any naming in recognition of an individual prior to discussing it with the individual or next of kin
  - Consult with external stakeholders in the community to the level of support or identify possible objections to the requested civic naming
  - Determine whether or not a special event is planned to coincide with the formal naming

# **Draft July 19th 2023**

## Authority of Issuance of By-Laws by the Town

- Standard by-law preamble -

## By-Law Objectives

To protect and develop the tree canopy within the Town of Gananoque for the benefit of all by improving air quality, shade, water retention and purification, ecological habit preservation, bio diversity and urban ascetic enhancement.

### **Definitions**

 "DBH" - Diameter At Breast Height – std. for the defining of tree size - diameter measured at 4.5 (1.372 m) feet above ground

### Municipal Trees

rees solely on or original to Town lands including parks boulevards and other Town properties.

he care and governance of the trees are the sole responsibility of the Town.

he planting and maintenance of trees are under the jurisdiction of the Town Council or designated employees and with guidance from the Trees and Trails Committee or any future advisory panel that is set up for this purpose.

### **Private Property Trees**

## <u>Definitions</u>

(1) T

rees solely on private property(s) or boundary trees, partially on private property(s) with origins on private property.

- Significant Tree" means a tree of 20 cm or larger in diameter at DBH
- "Dis tinctive Tree" means a healthy Tree that is considered by the Town to be of an uncommon species, or of size, or for other reasons, such as a notable heritage or gifted status in the Town of Gananoque and environment, and is such recorded and noted by the Town.

### <u>Requirements</u>

- 1. "Significant Tree" removal or alteration requires the completion of "Significant Tree Removal or Alteration Application Form" and if approved a "Significant Tree Permit" will be issued. Application to be submitted either by owner of property or certified tree service.
- The application will include: reason(s) for removal or alterations, alternative options to removal, and replacement plantings or other compensatory enhancements to the Town's urban forest as required.
  - A professional report, such as by an arborist or building contractor, may be required in cases that it is apparent that a qualified assessment is required.
- 2. "Distinctive Tree" requires Town Council specific approval for any alteration, removal or relocation.

### Application for:

### "Permit for Removal or Alteration of Significant Tree"

- to be submitted by owner or professional tree service
- nominal fee for application process (possible no fee by-law introduction period to be considered)
- contact info of owner and tree service if applicable
- dates and times of potential inspection if required
- location and description of tree including photos, site plan or drawings
- reason for intended work
- description of intended work

- · alternative options considered
- proposed replacement plantings if required as appropriate to work proposed

### **Permitting**

- application reviewed and assessed by Town
- further clarification or inspection as required
- issuance of permit or letter of denial with timeline for work and plantings
- follow-up inspection
- · permit validity time frame

### **Emergency Work on Dangerous Tree**

 in the case of a recognized immediate danger due to an unsafe tree or limb - all attempts to contact the Town must be made in a timely manner prior to mitigation work if at all possible

## **Enforcement**

- By-Law officers to be notified of any failure of conditions noted by town
- citations and fines imposed after given time allotment
- appeals process defined with cost incurred if unsuccessful appeal
- arbitrator appointment process defined
- tax roll levy for unpaid fines and warning and/or prohibition of tree service company from work in Town for allotted time and fine
