A fundraising campaign is underway to purchase new beds and mattresses for residents of the only long-term care home in Gananoque. Launched by Gibson Family Health Care Charitable Foundation, the campaign will improve the health and safety of seniors at Carveth Care Centre by replacing outdated medical equipment. Owned and operated by the Gibson family of Gananoque, Carveth Care Centre wants to replace 40 older style beds & mattresses with state-of-the-art equipment designed for wound care and for people who are at risk of falling.

2. HOW WILL THE PROJECT ENHANCE THE TOWN OF GANANOQUE?

This campaign will help Carveth Care Centre purchase specialized medical equipment to enhance the quality-of-life of residents as well as accommodate their unique medical needs. Working to reach a campaign goal of \$80,000, our home plans to purchase 40 new beds for the comfort and safety of long-term care residents. The upgrades will help hundreds of people over the next 20 years.

We can prove through our statistics that this equipment will benefit the most vulnerable members of our community AND help the health care workers who provide essential nursing care.
