### **RECOMMENDATION:**

THAT, the Council of the Town of Gananoque authorizes the Mayor and Clerk to enter into an agreement with G. Tackaberry and Sons Construction Ltd., for the purpose of conducting the annual asphalt resurfacing program as requested under RDS-2015-03 at an upset limit of \$514,480.58 including H.S.T.

### **BACKGROUND:**

The Council of the Town of Gananoque has taken a proactive approach to the annual maintenance of the streets in Gananoque. Over the last several years the Town has benefited from the annual asphalt resurfacing program and the continued commitment will allow for further gains in the resurfacing activities throughout town.

### **INFORMATION/DISCUSSION:**

As part of the annual asphalt resurfacing program, staff tendered for planned asphalt work. The tenders were advertised and closed February 20<sup>th</sup> 2015, there were five bids received.

### **FINANCIAL CONSIDERATIONS:**

This portion of the project can be completed within the allocated budget for 2015 Annual Asphalt Resurfacing Program. The remainder of the budget will be used for other hard top maintenance items, such as crack sealing and other asphalt maintenance work. Some of these items will be tendered jointly with the County to take advantage of economies of scale.
