HUDSON BRIDGE REPLACEMENT
NOTICE OF COMPLETION**

In order to address the significant structural deficiencies exhibited by the existing wrought-iron, pin-connected Pratt Through-Truss Bridge located on Machar Street, the Town of Gananoque is proposing to replace the structure with a new modular bridge. The new structure would be located at the same location and make use of the existing abutments and ballast wall. These works are planned to be completed by late 2019 at an estimated cost of **\$1,500,000**.



The above project is being planned under **Schedule B** of the **Municipal Class Environmental Assessment**. Subject to comments received as a result of this Notice, and the receipt of necessary approvals, the Town of Gananoque intends to proceed with the design and construction of this project.
