

CORPORATION OF THE TOWN OF GANANOQUE

**BY-LAW NO. 2012-077**

**BEING A BY-LAW TO ESTABLISH FEES AND RATES FOR WATER AND WASTE WATER SERVICES PROVIDED BY THE MUNICIPALITY**

WHEREAS pursuant to Section 391(1) of the Municipal Act, 2001, a municipality may impose fees and charges on any class of persons for services or activities provided or done by or on behalf of it;

AND WHEREAS Section 398 of the Municipal Act, 2001 allows the municipality to add unpaid fees and charges to the collector's roll for the property and collect in the same manner as taxes;

AND WHEREAS pursuant to Part V of the Safe Drinking Water Act, 2002, as amended, states that the municipality must provide full cost recovery financial plans in accordance with Section 3 and 9 of the Sustainable Water and Sewage Systems Act, 2002 to the Minister for approval;

NOW THEREFORE the Council of the Corporation of the Town of Gananoque enacts as follows:

1. That quarterly billing water and waste water rates are established as follows:

**Other Charges and Fees:**

Occupancy Charges	\$25.00
Collection Charge	\$25.00
Late payment charges	5% of current charges
Turning water off/on for summer services	\$75/meter
Turning water off/on for non-payment	\$75

Services connected to the municipal water system but not connected to the municipal sewer system, commonly referred to as 'Water Only Accounts', shall be charged the Water Basic Charge plus the Water Rate per Cubic Meter charge times the water consumption.

2. That the fees established by this by-law shall come into force and effect on September 1, 2012.
3. That any by-law or motion inconsistent with this by-law is hereby amended.
