

CORPORATION OF THE TOWN OF GANANOQUE

BYLAW NO. 2014-010

BEING A BY-LAW TO APPOINT COMMITTEES OF COUNCIL AND TO APPOINT COUNCIL MEMBERS TO SPECIFIC BOARDS AND COMMITTEES OF THE TOWN OF GANANOQUE.

WHEREAS by Section 5 of the Municipal Act, 2001, S.O. 2001, c. 25, the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS Subsection 2 of Section 11 of the Municipal Act, 2001, S.O. 2001, c. 25, the powers of every Council are to be exercised by Bylaw;

AND WHEREAS the Police Services Act section 27 provides that a Police Services Board be established when a municipality provides their own police services.

AND WHEREAS the Library Act section 10 provides the requirements of a Library Board.

AND WHEREAS it is deemed expedient to establish advisory committees of Council and to appoint individuals thereto.

NOW THEREFORE the Council of the Corporation of the Town of Gananoque enacts as follows;
