#### **BYLAW NO. 2015-095**

# BEING A BY-LAW TO AUTHORIZE THE TOWN OF GANANOQUE TO AMEND THE MEMORANDUM OF UNDERSTANDING TO FACILITATE THE MANAGEMENT OF THE CUSTOMS DOCK BY THE ARTHUR CHILD HERITAGE MUSEUM.

WHEREAS by Section 5 of the Municipal Act, 2001, S.O. 2001, c. 25, the powers of a municipal corporation are to be exercised by its Council;

**AND WHEREAS** the Municipal Act, 2001, S.O. 2001, c. 25, provides that the powers of every Council are to be exercised by Bylaw;

AND WHREAS the Town of Gananoque has passed By-law 2015-077 authorizing the Town to enter into an agreement with the Historic 1000 Islands Village Foundation operating as the Arthur Child Heritage Museum (ACHM) for the purpose managing the westerly portion of the Customs Dock;

**AND WHEREAS** Council deems it expedient to set some specific guidelines with regard to the management of the westerly portion of the Customs Dock.

**NOW THEREFORE** the Council of The Corporation of The Town of Gananoque hereby enacts as follows:

- 1) That the Town of Gananoque is authorized to amend the Memorandum of Understanding (MOU) with the Historic 1000 Islands Village Foundation operating as the Arthur Child Heritage Museum (ACHM) by adding guidelines to said MOU with regard to the use of the westerly portion of the Customs Dock;
- 2) That the guidelines as to the use of the westerly portion of the Customs Dock shall be per the items set out Schedule 'A' attached hereto and forming part of this document.
- 3) That this by-law come into force and effect on the date of passing.

**READ THREE TIMES** and finally passed this 08<sup>th</sup> day of September, 2015.

## ADDENDUM #1 TO MOU WITH THE ARTHUR CHILD HERITAGE MUSEUM FOR THE MANAGMEENT OF A PORTION OF THE TOWN-OWNED CUSTOMS DOCK.

### RESERVATION PROTOCOL

ALL RESERVATIONS TO BE MADE THROUGH THE ACHM, FEES ARE PAYABLE TO THE ACHM.

### SUGGESTED FEE SCHEDULE ( subject to change by the ACHM as authorized in the MOU.)

2016 SUGGESTED FEE SCHEDULE

Day Visit

Flat Rate

\$40.00

Overnight Stay

\$1.70 per foot

These fees apply to all Commercial Vessels and/or TIBM vessels. Transient vessels are still welcome to enjoy 2 hour courtesy dockage when the reserved sign is not out.

Management and Staff of the ACHM will continue to monitor and maintain order on the dock.

### Recommendation for the balance of 2015

- That for the remainder of the 2015 season fees for the TIBM be waived to allow time for them to
  prepare, either by completing construction of their planned dock, or time to put an appropriate budge in
  place for the dockage fees in 2016.
   TIBM must coordinate all remaining 2015 dockage requests through ACHM.
- That the fee for overnight dockage should apply to any vessels not currently reserved for the 2015 season and then to all vessels from that point on.
- ACHM Director Linda Mainse has been consulted and is in agreement with this recommendation for the balance of 2015.
- That a letter is to be sent to all parties from the Town outlining the approved Reservation Protocol and giving authorization for the Arthur Child Heritage Museum to manage the portion of dock as indicated in Memorandum of Understanding approved by Council July 7, 2015.
