STRATEGIC PLAN COMMENTS:

Sector 6 – Governance – Strategic Initiative #4 – Town Council will ensure openness and transparency in it operation.

Sector 3 – Financial Sustainability - Strategic Initiative #1 – Ensure that Gananoque is and remains an affordable place to do business and raise a family.

BACKGROUND:

Council Motion #19-178 approved staff's recommendation to use the Modernization Funding in principle, for the replacement of aging water meters. Staff, subsequently issued a Request for Proposal being RFP-UTIL-2019-01, for the Supply, Delivery, and Installation of Water Meters. That contract was awarded to Neptune Technologies Group, and executed on November 21, 2019, by the Mayor and Clerk.

INFORMATION/DISCUSSION:

As of February 7, 2020, Neptune Technologies Group has commenced the replacement of meters throughout Town, identified in the Request for Proposal. The Request for Proposal document identified a total of 1,222 meters to be supplied and installed, ranging in size from 5/8" to 1". The intent of the contract was to replace the balance of residential meters throughout Town that haven't been changed/updated to the new RF meters, identical to the ones the Town is changing under this contract.

Although the contract identifies replacement of the balance of residential meters that haven't been replaced in recent years by Town staff, it does not afford any contingency for unknown's, such as supply and installation of building control valves, line freezing, minor or normal carpentry, access to crawl spaces (requires 2 technicians), and minor, normal or

major plumbing modifications. Staff do not anticipate that every property will present any one, or combination of these issues, however there is a level of uncertainty as we are ramp up this program. That being said, the prices for the aforementioned works are reasonable, and range from \$35 each (supply and installation of building control valve, up to 3/4") to \$125 each (line freezing).

The main reason that staff are requesting the balance of the Modernization Grant to be made available for change orders for the Meter Replacement Program, is to replace/upgrade the balance of the 1 $\frac{1}{2}$ ", 2", 3"& 4" meters throughout Town, which are associated with commercial properties. There are a total of 20 – 1 $\frac{1}{2}$ " meters, 10 – 2" meters, 4-3" meters, and 1-4" meters throughout Town.

APPLICABLE POLICY/LEGISLATION:

Procurement By-law No. 2015-087.

FINANCIAL CONSIDERATIONS:

Neptune's bid price, including the supply and installation of 1,222 residential meters, is \$526,414.65 (Net HST inclusive). The modernization funding received by the Town is in the amount of \$650,720, leaving an available balance of \$124,305.35 in the Modernization Grant account.

The following outlines how the balance of the Modernization Grant would be utilized for this Meter Replacement Program to upgrade/replace the 1 $\frac{1}{2}$ ", 2", 3" & 4" water meters, and leave a contingency for unknown, isolated issues related to the upgrade/replacement of all meter sizes, sized 5/8" through 4".

The total price for the above additional meters is \$57,087.36 (Net HST inclusive), which would leave approximately \$67,218.64 as a contingency for change orders pertaining to existing unknown issues at properties.

Staff have received an inquiry regarding leasing space in the parking lot beside the Visitor Centre for the purpose of a bike rental operation.

In previous years, bikes were available for rent from this location through a private company. The operator installed a bike rack that was available for public use. Rental bikes were available for rental online. Visitor Centre staff would assist with the online booking. There were no fees paid to the Town. This operator will not be offering this service in 2020.

INFORMATION/DISCUSSION:

The availability of bicycle rentals adds a positive opportunity for those visiting Gananoque to explore our community.

As per Procurement By-law No. 2015-087 staff recommend issuing a Request For Proposals for such a service to be located beside the Visitor Centre. Signage opportunities exist in front of the Visitor Centre in addition to Visitor Centre staff easily being able to direct inquires to the operator.

This matter is time sensitive as operators require the ability to respond and prepare for the upcoming season.
