Dear Sir/Madam,

The Town of Gananoque would like to remind Short Term Accommodation owners that all short term rental properties (including AirBnB, VRBO or HomeToGo) require planning approval and a license to operate. This includes all Heritage Tourist Inns, Bed and Breakfasts and Short Term Accommodations.

Following the Local Planning Appeal Tribunal decision of May 2021, By-law No. 2019-125 (being a By-law to Amend the Development Permit By-law) is now in effect and applies to all Short Term Accommodations (rentals of less than 28 consecutive days).

By-law No. 2019-125 outlines criteria and requirements for Heritage Tourist Inns, Bed and Breakfasts, and Short Term Accommodations. This includes provision of guest parking spaces as well as Ontario Fire Code and Ontario Building Code requirements to ensure the safety of you and your guests. A one-time Development Permit is required prior to obtaining an annual license to operate.

Please be advised that the Town has observed that your property has been advertised in 2021 as a Short Term Accommodation and our records indicate that a permit under the Development Permit By-law has not been obtained for this use.

It is the responsibility of all Short Term Accommodation owners to ensure compliance with all municipal by-laws in order to operate.

In 2022, the Town will be actively investigating non-compliant Short Term Accommodations. Any non-licensed Short Term Accommodation properties that continue to advertise their listing without proper approvals may be subject to enforcement of orders or fines up to \$1,000 as outlined within the by-law and approved by the Ontario Court of Justice.

Therefore, we respectfully ask that you ensure that all proper approvals are in place as we look forward to welcoming all visitors, family and friends to Gananoque in 2022.

In 2022, the Town of Gananoque will be actively investigating non-compliant Short Term Accommodation properties, which may lead to enforcement through fines or orders where necessary. OBSERVATIONS FROM FIRST FESTIVAL

*Entertainment:

All went very well, however improvements to the Joel Stone Heritage Park to include more daytime activity and use of the main stage, particularly Friday afternoon, and during the Lions Club "Burgers & Dogs" event and Sunday afternoon.

The Ollin Drummers to perform longer with more drummers and audience participation.

The children's play "The Little Prince" worked very well at the Lions Pavilion on the Joel Stone "Berm"

The History Museum Concerts on the verandah went well. Should run earlier in the day say 2pm for each of the three days.

The magician "Ray Anderson" could perform longer, needed better sound and 'Circus Jonathan" following a good idea, but longer using better sound.

ALL EVENING PERFORMANCES well attended and highly successful, appealing to varied audience tastes.

*Marketing

The lack of newspaper advertising problematic, however posters, programs and radio ads went well. The facebook ads for the family shows worked, however more dollars needed to increase reach, greater targeting Signage lacking and needed at every event. Information at various sites (Visitors Centre, Town Web site, MyFm Now, etc) all must have the same information.

*Budget

In order to continue more funds needed to cover park rental, insurance and produce a larger event. \$10,000.00 request.

*Date

The 1000 Islands Waterfront Festival better the AUGUST 1st long weekend not partnering with the Poker Run. Perhaps a "boat Show" would work
