#### PROJECT DESCRIPTION

#### TO: Mayor John Beddows and Members of Town Council of Gananoque Ontario

We are writing to Council to ask permission to have Council endorse in writing the First People's Performing Arts Festival events this year. We are asking for a letter of confirmation of this commitment and also for a financial commitment of \$8,000. We are attaching our proposed budget for your perusal. Last year Council was very generous in its support of this Festival, and we trust that this positive reinforcement of the importance of this event will continue. We note that we will fill out the required forms depicting insurance, persons responsible for overseeing the events and any other information that may not be included in this current letter. We do note that the Canadian Heritage Grant deadline is January 31, 2024 and it requires written confirmation of the Town/Municipality support. We do understand that we in fact are told to submit this application in the Second Intake, but that deadline is far past what is required for the Canadian Heritage submission. Hence the current request.

The First People's Performing Arts Festival is organized and managed by the First Peoples' Circle of the Thousand Islands and works under the umbrella structure of King Street Productions which is an incorporated Non-Profit Arts Organization under a Federal Charter.

This year the 8<sup>th</sup> edition of this Festival is being presented from September 19 to September 22, 2024 under the theme of *Awakenings*. The festival continues to grow each year including the previous years during the pandemic.

The programming for this year will focus on a theatrical play entitled **Sometimes When I Dream**a musical presentation written and composed by Mohawk Kevin John Saylor, a resident of

Gananoque and Kahnawake. The performers will be primarily youth from Kahnawake and

Gananoque, who will collaborate with Mr. Saylor in the creation of the piece, which depicts a Musical fable about the first contact between Indigenous Peoples and European Explorers. Added to this will be the story tellers, recounting their tales of Indigenous history and traditions, along with dancers and as always, the famous drummers who tirelessly accompany most performances and events throughout the Festival. Outdoor events will include the placing of the Tiny Shoes on the King Street side steps of Town Hall, a smudging ceremony and teachings in the park in front of Town Hall on the Sunday morning followed by a Reconciliation Walk along King Street to Stone St and along to the First People's Park. Preliminary schedule and location is found below.

The popular Makers Indigenous Craft Market will return featuring the intricate artistic work created by these artists. An Indigenous film – *The Incredible 25<sup>th</sup>. Year of Mitzi Bearclaw* - will be shown on Friday evening. There will be a closing Feast at the end of the Festival on the Sunday evening, which was done last year and proved to be extremely popular. Many of the other actual events cannot be listed at this time, as it is still too early in the process, but as in previous years, everything is focussed on the celebration of the Indigenous contributions to our heritage and the recognition of the importance the Indigenous communities play in our history both past and present.

This year we will be applying again to the Department of Canadian Heritage for the Local Festivals program, the deadline for which is January 31, 2024. One of the requirements of this application is the commitment of support from the town/municipality in which the Festival is taking place as well as the financial contribution to the Festival this town/municipality will commit. This is a form which requires a signature from the proper authority for the town/municipality.

The success of this Festival is such that we have received several sponsorships from the community including Nature's Way Landscaping, Gan Chev Olds, MyFM Radio 99.9, Red Ruby Air BnB, Maple Leaf Restaurant and others, including several churches of various denominations that are seeing this as an opportunity to support ongoing Truth and Reconciliation initiatives. We feel certain that the list of supporters will continue to expand and grow. We are also enthusiastic for even greater participation from the Indigenous communities from Quebec to southern Ontario. The community of Gananoque has also been very

supportive of this Festival and three years ago, the First People's Park of the Thousand Islands on the Sacred River waterfront of the St. Lawrence was officially dedicated and named in the presence of Indigenous and allied members of the First Peoples' Community.

As an intentional focus of the First Peoples' Performing Arts Festival of the Thousand Islands has been education through the sharing of Indigenous Arts and Culture, it has been very validating to get wonderful feedback from many non-Indigenous people. Attendees of the various events have told us how very much they have appreciated and learned through the performances, the storytelling, and the ceremonial events that they were invited to participate in. We are aware of Tourists who come Gananoque, particularly hoping to discover some of the pre-settler identity of this region, wanting to learn about the First Peoples on whose land the towns and cities along the Saint Lawrence River have been built. These tourists want to see our region's historical sites and are also hoping to learn about the Indigenous culture, both historical and contemporary. They are delighted to discover the First Peoples' Performing Arts Festival of the Thousand Islands and all of its educational elements.

The attendance at last year's Festival was constant and exciting. For each event there were a minimum of 50 participants and often 75 or more. For the headliner — Barbara Diabo — due to a technical difficulty she was unable to fulfill her full performance agreement during the actual festival but did perform a truncated version of her work during the Festival and honoured her commitment by returning to do the full performance of *Sky Dancers* on November 12<sup>th</sup> which was well attended and received with great enthusiasm.

Advertising for this event will begin in early July and a poster will be created specifically for this year's events, which will highlight the various performances and performers along with the sponsors and contributors. It is distributed through several Facebook on-line groups as well as instagram and others. There will also be hard copies postered throughout Gananoque as well as in Kingston and other communities in the surrounding areas.

t is to be noted that all participants in the programmes will be paid and all access to all the events will be free of charge to everyone.





The administrative management of the Festival is overseen by seasoned professional Arts Administrator Jane Needles, and Professional Artistic Director Frayne McCarthy who are the leads of King Street Productions (KSP). There are positions for student employees under the Youth Employment Grant program of Canadian Heritage, but the decisions on these grant applications are unknown at this time. However, we have been successful in obtaining them for the past several years. All programming is determined by the members of the First Peoples Circle of the Thousand Islands.

We trust that we have provided sufficient information about this event, but if there are any details missing, please do not hesitate to contact the undersigned.
