Council speaks through by-law or resolution and therefore no individual member can direct staff unless Council has delegated that authority to the Member. In addition, the combined effect of section 11 of the Code of Conduct makes any attempt to direct staff a breach of the Code.

You are hereby directed to refrain from contacting and attempting to direct staff on the topic of COVID or any other municipal issue that you feel needs to be relayed to staff and that any communication must go through the Mayor to decide what, if anything, gets forwarded. Going forward, all staff will be directed to simply delete or ignore your emails.

Further, you can address constituent concerns through the Mayor, if those concerns happen to be anti-vax/anti-mask etc.

I trust that Council's position on this matter is clear to you.
