Ms Dickson presented a letter to the committee requesting assistance with ice costs for the 2011/12 ice season for the Junior B's. The committee reviewed this and will reply to Ms. Dickson suggesting that she make her request to Council asking for a Council Grant to help offset the cost of ice for the season. - Summer Ice
 - Management and Council Representative Joe Jansen have met with the major ice users as well as the Curling Club regarding rental of August ice time. Management is asking for a commitment of at least 10 hours of ice rental a day during this period to make it feasible to continue with early ice. Each of the clubs will respond following their meeting.
 - The Curling Club have agreed to move their spiel by one week which will allow us to turn the plant on a few days later.
 - o A final decision on early ice will be made once all clubs have replied.
- Contact with YMCA
 - o Suzanne will invite YMCA representative to our next committee meeting.
- Ball Theresa reported that there is enough interest in ball to form an executive.
 She will meet with Township Recreation Co-ordinator in the near future to discuss the opportunities of working together to bring ball back to the community.

 We are still working on sponsorship for the gates, fencing etc.
 - Works staff are assisting with the prep for the field.
