Consolidation of Trees and Trails Advisory Panel under the Director of Parks and Recreation

The Trees and Trails Advisory Panel (the Panel) reviewed the *DISCUSSION ON A PROPOSED CONSOLIDATION OF THE TREES AND TRAILS OPERATIONS UNDER THE DIRECTORSHIP OF THE GANANOQUE PARKS AND RECREATION DEPARTMENT* (the proposal).

Discussion about including Parks in the Panel and contracting a professional arborist to assist the Directors of Parks and Recreation and Public Works when determining if a tree should be removed and assist in an annual tree hazard assessment.

Spring Projects and Who Does What

Pitch Pines:

There are ten pitch pines to be lifted and planted in May. Director of Parks and Recreation will coordinate planning, Director of Public Works will assign staff once planning is complete. Funding for the lifting is available in reserve funds generated from tree nursery.

Discussion of finding an additional location for a plaque commemorating the pitch pine as the official tree of the Town of Gananoque (the Town). Locations to be considered by Jim and Peter: near waterfront, recreation centre, arena, near a trail. Further discussion of creating a pamphlet about the pitch pine.

Wood Chip Spreading:

The CAO is working with Joyceville Institution to develop a Memorandum of Understanding relating to the Town participating in a Work Release Program that would involve inmates would undertaking work for the Town in the spring and summer months. Wood Chip Spreading on the trail network discourages grass and weed growth and has been identified as a task the inmates could complete during this time. Dwayne Fletcher has volunteered his own time to supervise this operation on behalf of the Town. The Director of Public Works will send the Personnel Screening Consent Form to Dwayne Fletcher.

Spring Cleanup and trail repairs:

Clean up and construction needed at stair bypass by No Frills. Director of Parks and Recreation to visit the location in the next couple of weeks and assign staff to identify and photograph the bypass. Director of Public Works to provide staff/backhoe to move large rocks associated with the cleanup.

Wooden steps at end of Arthur St (South end of MacLean Loop):

Stairs are rotted and need to be replaced, preferably early in the spring. Director of Parks and Recreation to visit the site with a contractor to identify the scope of work.
