1.0 ABORIGINAL ENGAGMENT

1.1 Summary of Aboriginal Engagement Related to the Stage 4 Archaeological Assessment

The Stage 4 archaeological assessment of the Island Harbour Site (BbGa-16) which was to be impacted by the proposed development at 175 St. Lawrence Street, Gananoque involved engagement with two First Nations: the Mohawk Council of Akwesasne and the Mohawks of the Bay of Quinte - Tyendinaga Mohawk Territory. Engagement was sought with both communities as the property lies within an area with overlapping Traditional Territory.

No engagement had been undertaken during the Stage 1 assessment, and this was continued at Stage 2 given the small likelihood of encountering pre-Contact material on a highly disturbed former industrial site. During the course of the Stage 2 assessment which involved the excavation of 18 slit trenches across the property, however, two small mending sherds of Woodland pottery were recovered from one trench in the northwest corner of the property, triggering both a Stage 3 assessment and a requirement for Aboriginal engagement.

Past Recovery Archaeological Services Inc. (Past Recovery) contacted both Ms. Amy Cowie, Research Assistant, Mohawks of the Bay of Quinte - Tyendinaga Mohawk Territory, Ms. Cactus Cook Sunday of the Mohawk Council of Akwesasne and Mr. Curtis Lazore, Environmental Assessment Officer, of the Mohawk Council of Akwesasne, via emails and telephone calls to advise both communities of the results of the Stage 2 and to seek their involvement and input towards the Stage 3 assessment. Letters with a formal request for engagement were addressed to Grand Chief Mitchell and Council of the Mohawk Council of Akwesasne and to Chief Maracle of the Mohawks of the Bay of Quinte - Tyendinaga Mohawk Territory and sent by Mr. Andrew Ball, the project manager for Island Harbour Club Inc., on July 28th, 2014 (Figures 1 and 2). The request for engagement was approved by Chief Maracle of the Mohawks of the Bay of Quinte - Tyendinaga Mohawk Territory on August 20th, 2014 (Figure 3).

Past Recovery staff had an on-site meeting with Ms. Amy Cowie and Mr. Andrew Ball on August 21st, 2014, where Ms. Cowie indicated that she had been co-ordinating with Mr. Lazar of the Mohawk Council of Akwesasne, wherein a letter from the Mohawk Council of Akwesasne would not be required, but that a monitor from the Mohawk Council of Akwesasne would be available to participate in the fieldwork and would be the on-site representative for both communities. The site monitor, Mr. Lloyd Benedict, jr., was present for the duration of the Stage 3 archaeological assessment on the 26th and 27th of August, 2014, and for most of the Stage 4 archaeological assessment on the 29th of August and the 2nd, 3rd, 4th and 5th of September, 2014. Final excavation reports will be submitted to both communities for review.

This letter is to respectfully initiate a process of engagement with the Mohawks of the Bay of Quinte – Tyendinaga Mohawk Territory regarding our planned development of a property at 175 St. Lawrence Street in Gananoque. It is our understanding that this property lies within the Traditional Territory of concern to both the Mohawk Council of Akwesasne and the Mohawks of the Bay of Quinte - Tyendinaga Mohawk Territory. As a result, we are seeking engagement with both communities.

A Stage 1 archaeological assessment was completed by Golder Associates Ltd. in May, 2014. This assessment identified the study area as having archaeological potential for structural remains from nineteenth century buildings as well as for pre-Contact resources given the proximity to the St. Lawrence River and the Gananoque River. As such, the Stage 1 assessment made the following recommendation:

 That a Stage 2 archaeological assessment be conducted by a licensed archaeologist, prior to construction. The Stage 2 assessment should consist of mechanical excavation of trenches (1 x 4 m.) to be situated based on features documented in historic maps and Fire Insurance plans of the study area as well as a sampling of other portions of the property.

Island Harbour Club Inc. subsequently retained Past Recovery Archaeological Services Inc. to undertake the Stage 2 archaeological assessment. The fieldwork for this assessment was completed on July 2nd, 2014, and consisted of the mechanical excavation of 18 slit trenches across the property (Figure 1). The Stage 2 trenches revealed extensive disturbance across the property, primarily related to twentieth century industrial development which included a large

milling operation with multiple buildings, as well as foundry waste storage and an oil storage facility with underground tanks. As a result of this industrial development, the site soil is contaminated and will require removal as part of the site remediation process. A small number of mid-nineteenth century artifacts were recovered from a single test trench in the western corner of the property (coloured magenta on Figure 1), together with a single sherd of Woodland pottery.

Following the completion of the Stage 2 fieldwork, Past Recovery advised us that a Stage 3 archaeological assessment would be required in the area surrounding the trench containing the sherd of Woodland pottery and the mid-nineteenth century artifacts (shaded yellow on Figure 1). Past Recovery also contacted both Ms. Amy Cowie, Research Assistant, Mohawks of the Bay of Quinte, and Mr. Curtis Lazore, Environmental Assessment Officer, Mohawk Council of Akwesasne, via email to advise both communities of the find and to seek the involvement of both communities as the project moves forward. This letter seeks to formally request this engagement.

The Stage 2 analysis and report preparation is still underway but the attached plan (see Figure 1) shows the study area with the location of the Woodland pottery find. Figure 2 shows the context of the find and Figure 3 is a picture of the single sherd of pottery. We will provide you with a full copy of the Stage 2 report as soon as it has been completed by Past Recovery. If you require any additional information regarding the archaeological findings or the larger project, please do not hesitate to contact us.

2.0 DETAILED SITE LOCATION INFORMATION

A handheld Geographic Positioning System (GPS) receiver was used to record the location of the archaeological site identified in the Stage 2 and 3 assessments. The unit used was a Garmin eTrex Legend. Using the built-in patch antenna, the unit is capable of calculating its position to within 15 metres (95% typical). In addition, this unit is capable of receiving Wide Area Augmentation System (WAAS) position correction signals, which can improve the accuracy of the position reporting to within two metres (under ideal conditions). The reference coordinate system used was the latest revision of the World Geodetic System, WGS84. The entire study corridor is located within the Universal Transverse Mercator (UTM) coordinate system Grid Zone 18T.
