APPLICATION FOR PERMISSION Under Ontario Heritage Act

One original and four copies of a complete application form signed including declaration of applicant.
One copy of the deed of property
One copy of drawings, specifications, site/landscape plan, photographs, paint chips, additional notes as necessary.
One copy of the location of all natural and artificial features on the subject lands including buildings, water, roads, easements, etc.

When is a Heritage Permit Required?

Under the *Ontario Heritage Act, R.S.O 1980*, any new construction or "alteration" to a property that has been designated requires a Heritage Permit. Heritage Permits are issued through the Town of Gananoque and require Municipal Heritage Committee and/or Council approval.

The Ontario Heritage Act, R.S.O 1980 defines "alter" or "alteration" as "to change in any manner and includes to restore, renovate, repair or disturb".

Some examples of work requiring a Heritage Permit include:

- Addition and/or alteration to an existing building or accessory building
- · Replacement of windows or doors, or a change in window or door openings
- Change in siding, soffit, facia or roofing material
- · Removal and/or installation of porches, verandah and canopies
- Removal and/or installation of cladding and chimneys
- Removal and/or installation of decks, fences, gates, trellises, arbours and gazebos
- Change in trim, cladding or door colour(s) or painting of masonry
- · Re-pointing of brick

Some examples of work NOT requiring a Heritage Permit include:

- Minor repairs to siding materials
- Repairs to, and replacement of, eaves troughs and down spouts, unless they are integral to the heritage character of the building (i.e. decorated metal, original to the building)

This application form is also for minor work that doesn't require a building permit, but may nevertheless require a heritage permit. Typical small projects that require a heritage permit without other approvals include:

- Replacement siding
- · Cleaning or re-pointing masonry
- · Replacement windows or doors on elevations visible from the street
- Removal of architectural building elements (e.g. shutters, doors, trim, etc.)
